## <u>ORDER</u>

As per letter read as 1<sup>st</sup> above, sanction had been accorded for shifting the place of Assistant Engineer (Civil), temporarily from the Civil Maintenance Section Chembukadavu to the Adyanpara SHEP, for proper monitoring and execution of large quantum of Civil works in connection with the flood rehabilitation and protection works at Adyanpara SHEP. The working arrangement has been sanctioned for a maximum period of six months or till the completion of the work whichever is earlier. Accordingly, the place of Assistant Engineer (Civil) was shifted to the Adyanpara SHEP and Sri. Sharfudeen. A, Sub Engineer (Civil) has been assigned the full additional charge of Assistant Engineer (Civil), Adyanpara SHEP, with effect from 03 - 06 - 2019. Subsequently, as per Order read as 2<sup>nd</sup> above, sanction was accorded for continuing the above arrangement for a further period of 6 months for proper monitoring of the Civil works at Adyanpara SHEP. The extended period expired on 01-06-2020.

The Chief Engineer (Generation & PED) has reported that, Sri. Sharfudeen. A, (EC-1049493), Sub Engineer (Civil) in charge at Adyanpara is supervising and measuring the Civil works till date. The flood related Civil works under Adyanpara SHEP are in progress and yet to be completed and some other Civil works are also progressing under the Generation Sub Division Malampuzha. The Chief Engineer (Gen. &PED) has furnished a detailed list of all Civil works in progress/to be executed under Generation Sub Division Malampuzha. It is reported that there is no major Civil works at Chembukadavu SHEP for the time being. Considering all the above, the Chief Engineer (Gen.& PED) has requested sanction for retaining the place of Assistant Engineer (Civil) at Adyanpara SHEP till December 2021.

The matter was placed before the Full Time Directors as per Note read as 5<sup>th</sup> above. Having considered the matter in detail, the Full Time Directors in the meeting held on 30-04-2021 resolved to accord sanction to retain the place of Assistant Engineer (Civil) at Adyanpara SHEP, which has been shifted temporarily from Maintenance Section, Chembukadavu, till December 2021.

Orders are issued accordingly.
