ORDER

M/s. Ashiyana Filament & Ropes (LCN 5/5812) was a non-live HT consumer, which comes under Electrical Circle, Manjeri. The HT service connection in respect of the consumer was disconnected on 02.05.2017 and physically dismantled on 28.02.2018 due to the default of payment of current charges. The consumer has an outstanding arrear amounting to ₹ 14,46,579/- as on 31.03.2021 (including interest) towards arrear current charge.

The Revenue Recovery action was initiated against the consumer on 09.12.2020 for realising arrear amount through the District Collector, Malappuram and the Revenue Recovery action is still pending in the Malappuram Collectorate.

Now the consumer as per letter read as 2nd above has requested for OTS Scheme sanctioned by KSEBL as per the order read as 1st above. Accordingly, the matter was placed before the Full Time Directors, KSEBL as per the note read as 3rd above.

Having considered the matter in detail, the Full Time Directors in its meeting held on 31.03.2021 resolved to permit the consumer M/s. Ashiyana Filament & Ropes to clear the arrears under OTS Scheme 2021.

The decision to pass orders as above was taken on 31.03.2021, which is during the currency of Model Code of Conduct (MCC) as ordered by the Election Commission of India. Order has now been issued after lifting of the Model Code of Conduct.

Orders are issued accordingly.
