#### **ORDER**

M/s. Meenachil Rubber Marketing & Processing Co-operative Society Ltd. (LCN 5/521) was a non-live HT consumer, which comes under Electrical Circle, Pala. The HT Service connection in respect of the consumer was disconnected on 01.09.2018 and physically dismantled on 01.10.2019 due to default of current charges. The consumer has an outstanding arrear amounting to ₹ 2,62,411/- as on 31.03.2021 (including interest) towards current charges.

The Revenue recovery action was initiated against the consumer on 14.05.2020 for realising arrear amount through the District Collector, Kottayam and the Revenue Recovery action is still pending in the Kottayam Collectorate.

Now the consumer as per letter read as 2<sup>nd</sup> above has requested for OTS Scheme sanctioned by KSEBL as per the order read as 1<sup>st</sup> above. Accordingly, the matter was placed before the Full Time Directors, KSEBL as per the note read as 3<sup>rd</sup> above.

Having considered the matter in detail, the Full Time Directors in its meeting held on 08.04.2021 resolved to permit the consumer M/s. Meenachil Rubber Marketing & Processing Co-operative Society Ltd. (LCN 5/521) to clear the arrears under OTS Scheme 2021.

The decision to pass orders as above was taken on 08.04.2021, which is during the currency of Model Code of Conduct (MCC) as ordered by the Election Commission of India. Order has now been issued after lifting the Model Code of Conduct.

Orders are issued accordingly.
