ORDER

M/s. Meenachil Co-Operative Rubber Marketing & Processing Co-Operative Society (LCN 32/3542), an HT consumer under Electrical Circle Pala has outstanding arrears as on 28.07 2021 (including interest) towards current charges from 08/2015 to 12/2016 amounting to ₹ 9,32,332/-. Due to the default in payment of current charges, the service connection was disconnected on 01.06.2016 and subsequently dismantled on 08.08.2018 as per rules.

The Revenue Recovery action was initiated against the consumer for realizing the arrear amount through the District Collector Kottayam on 17.04.2019. The Revenue Recovery action is still pending before the District Collector, Kottayam.

Now the consumer as per letter read as 2nd above, has requested for OTS scheme 2021 sanctioned as per order read as 1st above.

The matter was placed before the Full Time Directors as per note read as 3rd above.

Having considered the matter in detail, the Full Time Directors, in its meeting held on 31/3/2021 resolved to permit the consumer M/s. Meenachil Co-Operative Rubber Marketing & Processing Co-Operative Society (LCN 32/3542) to clear the arrears under OTS Scheme 2021.

The decision to pass orders as above was taken on 31.03.2021, which is during the currency of Model Code of Conduct (MCC) as ordered by the Election Commission of India. Orders has now been issued after lifting the Model Code of Conduct.
