## ORDER

M/s Palode Paper Mills (P) Ltd. (HTB 21/3379) a non-live HT consumer under Electrical Circle, Kattakkada, Thiruvananthapuram (Rural) has outstanding arrears amounting to ₹ 8,05,43,394/- as on 31.03.2021 (including interest) towards current charges from 10/2001 to 8/2005. Due to the default of payment of current charges, the service connection was disconnected on 11.02.2005 and subsequently dismantled on 29.10.2005 as per rule.

The Revenue Recovery action was initiated against the consumer for realizing the arrear amount through the District Collector, Thiruvananthapuram. The Revenue Recovery action is pending before the District Collector, Thiruvananthapuram.

Scheme 2021 sanctioned by KSEBL as per order read as 1<sup>st</sup> above. Accordingly, the matter was placed before Full Time Directors, KSEBL as per note read as 3<sup>rd</sup> above.

Having considered the matter in detail, the Full Time Directors in its meeting held on 31.03.2021 resolved to permit the consumer, M/s Palode Paper Mills (P) Ltd. (LCN 21/3379) to clear the arrears under OTS Scheme 2021 subject to the terms and conditions in the order read as 1st above for OTS Scheme.

The decision to pass order as above was taken on 31.03.2021, which is during the currency of Model Code of Conduct (MCC) as ordered by the Election Commission of India. Orders has now been issued after lifting the Model Code of Conduct.
