Reducing contract demand from 175 kVA to 145 kVA and enhancing connected load from 479.7 kW to 528.911 kW in favour of M/s Hotel Aida, Kottayam (LCN 13/4322) under Electrical Section, Kottayam Central –sanctioned - Orders issued.

ORDER

The Deputy Chief Engineer, Electrical Circle, Kottayam, as per letter read as 4th above, sought directions in the matter of processing the application for reduction of contract demand and enhancement of connected load from M/s Hotel Aida, Kottayam, with a pending arrear of ₹6,68,352/-.

M/s Hotel Aida, an HT consumer under Electrical Section, Kottayam Central, seeks reduction of Contract demand from 175kVA to 145kVA and enhancement of connected load from 479.7kW to 528.911 kW.

The Special Officer, Revenue, has reported that the firm is having an arrear of ₹6,68,352/-(towards payment of electricity duty) pending realization (under litigation in WP(C)No. 30977/2010).

The consumer has produced the copy of an interim order issued by the Hon'ble High Court of Kerala dated 13.10.2010 in WP(C) No. 30977/2010 allowing the petitioner to remit the

electricity duty at the rate of 10 ps. per unit. The consumer had been paying their monthly electricity bills computing the Electricity Duty component @10 ps. per unit as per this order for a while, however as the final disposal in this WP (C) at the Hon'ble High Court was getting delayed, they decided later to remit the Electricity Duty @10% of total Electricity charge as generated in their monthly bills and this practice is being continued thenceforth.

The consumer has also produced the copy of the Board order read as 3rd above in connection with the Regularisation of connected load of M/s Little Flower Hospital, Angamaly, under Electrical Section Angamaly, having pending arrear amount towards Electricity Duty for realization.

The BO read as 3rd above related to the Little Flower Hospital, Angamaly and allowed for regularization of connected load despite pending arrears, considering the remarks of the Senior Law Officer read as 2nd above that 'enhancement of connected load or contract demand which is otherwise eligible, can't be impeded citing assumed arrear and any such denial is tantamount to deficiency in service and coercive action against the spirit of the interim order'. (In this case also, the arrears related to the demand for electricity duty @10% of the electricity charges discontinuing the earlier practice of assessing duty at 10 ps per unit, in compliance with the GO read as 1st above).

The matter of processing the application for reduction of contract demand and enhancement of connected load from M/s Hotel Aida, Kottayam with a pending arrear of ₹ 6,68,352/-was taken up with the Director (Finance) as per note read as 5th above, and the Director (Finance) decided that the consumer shall be asked to remit the dues.

Considering that the Full time Directors had since then sanctioned connected load and contract demand enhancement in several cases where the arrear disputes are pending before legal forums like the Appellate Authority, and considering that the connected load enhancement (though without change in contract demand) in a similar case of Angamaly Little flower Hospital where the dispute regarding the arrears (towards payment of electricity duty) is pending before the Hon. High court of Kerala was earlier granted as per BO read as 3rd above, and considering the remarks of the Senior Law Officer that 'enhancement of connected load or contract demand which is otherwise eligible, can't be impeded citing assumed arrear and any such denial is tantamount to deficiency in service and coercive action against the spirit of the interim order', the matter was taken up with the Director (Finance) for a review and the Director (Finance) suggested placing the matter before the Full Time Directors.

The matter was placed before the Full Time Directors as per note read 9th above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 23/04/2021

- Resolved to accord sanction to the Deputy Chief Engineer, Electrical Circle, Kottayam to process the application from the HT Consumer M/s Hotel Aida, (LCN 13/4322) with pending arrears of ₹ 6,68,352/- (towards payment of electricity duty) under dispute before the Hon. High Court of Kerala, for enhancement of connected load from 479.7kW to 528.911 KW and reduction of Contract Demand from 175kVA to 145kVA , after getting an undertaking from the consumer in stamp paper stating that they shall remit the pending arrears subject to the final judgment from the Hon. High court of Kerala.
- 2. Further resolved to direct the Law Section, KSEBL to take action to expedite the case regarding the matter, pending before the Hon. High court of Kerala.

Orders are issued accordingly.
