## ORDER

As per the letter read as 1<sup>st</sup> above the Chief Engineer (Distribution Central), Ernakulam has reported that the Deputy Chief Engineer, Electrical Circle, Ernakulam had invited tenders for the work of hiring a vehicle (Tempo Traveller) for fitting, mounting and transporting the cable fault locator with accessories for the use of APDRP Construction Division, Ernakulam. Nobody participated in the first tender and the work was re-tendered. Two tenders were received in the re-tender. The lowest bidder in the re-tender was Sri. Scaria C.E., Chitteth House, Mariyamangalam, Mamala P.O., Ernakulam (the existing contractor) who has offered a negotiated rate of ₹47.75/km for 1,000 km and ₹18/- for every additional km.

In the above circumstances, considering that the service of a vehicle is essential for attending faults, the Chief Engineer (Distribution Central), Ernakulam has requested sanction for hiring a vehicle (tempo traveller) from the lowest tenderer Sri. Scaria C.E., Chitteth House, Mariyamangalam, Mamala P.O., Ernakulam at the negotiated rate of ₹47.75/km for 1,000 km and ₹18/- for additional km for a period of one year with effect from 16/04/2021.

The matter was placed before the Full Time Directors as per the note read as 2<sup>nd</sup> above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 09/03/2021 resolved to accord sanction for hiring a vehicle (Tempo Traveller) for fitting, mounting and transporting the cable fault locator with accessories attached to APDRP Construction Division, Ernakulam for locating cable faults for a period of one year, from the lowest tenderer Sri. Scaria C.E., Chitteth House, Mariyamangalam, Mamala P.O., Ernakulam at the negotiated rate of ₹47.75/km for 1,000 km and ₹18/- for additional km for a period of one year with effect from 16/04/2021.
