ORDER

As per the letter read above the Chief Engineer (Distribution North), Kozhikode has reported that the tender cum auctions were conducted for two times for the sale of 121 numbered trees in the site of 1.5 MW solar power project at Nenmara. But the response was not good. The value assessed by the Social Forestry Division, Palakkad for the above numbered trees was ₹17,40,690/-. Hence re-auction was conducted for the third time on 03/03/2021. There were ten participants in the auction and no tenders were received. The highest rate of ₹8,61,800/- was offered by Sri. Aboobacker Sidique, S/o Abdulla, Puthanpeedika House, Kottapadam P.O., Mannarkkad.

The Deputy Chief Engineer, Electrical Circle, Palakkad has reported that the removal of trees from the site are necessary and inevitable for the ongoing construction works.

In the above circumstances, the Chief Engineer (Distribution North), Kozhikode has requested sanction to accept the rate of ₹8,61,800/- offered by Sri. Aboobacker Sidique, S/o Abdulla, Puthanpeedika House, Kottapadam P.O., Mannarkkad obtained in the re-auction conducted for the disposal of trees in the site of 1.5 MW solar power project at Nenmara.

The matter was placed before the Full Time Directors as per the note read as 2nd above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 08/04/2021, resolved to accord sanction for accepting the rate of ₹8,61,800/- offered in the re-auction conducted for the disposal of 121 numbered trees in the site of 1.5 MW solar power project at Nenmara offered by Sri. Aboobacker Sidique, S/o Abdulla, Puthanpeedika House, Kottapadam P.O., Mannarkkad.


