ORDER

M/s. Kerala Ceramics Ltd. (LCN 11/1105), is a live High Tension consumer which comes under the jurisdiction of the Deputy Chief Engineer, Electrical Circle, Kottarakkara. The consumer has long pending arrears which were accumulated due to irregular payment of current charges for the period from 04/1986 to 03/2006 & broken arrear from 08/2009 to 03/2013. Subsequently Revenue Recovery action was initiated against the consumer on 14.03.2017 for ₹ 14,99,86,695/-. As per the direction of Hon'ble Minister of Power, M/s. Kerala Ceramics Ltd submitted an affidavit on 13.11.2019 where in it was affirmed that the company will settle the dues to KSEBL within six months either by identifying and transferring land owned by company equivalent to the dues under OTS Scheme mentioned or through any other suitable means acceptable to both the M/s. Kerala Ceramics Ltd and KSEBL. Consequently, the District Collector, Kollam was requested to stall the Revenue Recovery action temporarily for a period of six months. The Consumer as per application dated 02.01.2020 had requested to settle the arrears under OTS 2019. As per Board Order read 1st above, sanction was accorded to the consumer to pay

the arrears under One Time Settlement 2019. But, the consumer failed to remit the arrear in OTS 2019.

Now the consumer has made a request read as 4^{th} above to settle the arrears under OTS Scheme 2021 as per the orders read (2) & (3). The matter was placed before the Full Time Directors as per note read 5^{th} above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 31.03.2021 has resolved to permit the consumer, M/s. Kerala Ceramics Ltd., Kanjirode (LCN 11/1105) to clear the arrears under One Time Settlement Scheme 2021.

The decision to pass orders as above was taken on 31.03.2021, which is during the currency of Model Code of Conduct (MCC) as ordered by the Election Commission of India. Orders has now been issued after lifting the Model Code of Conduct.
