#### **ORDER**

M/s. High-Tech Feed Mixing Plant, (KEPCO), Mala, KSPDC LTD, Kuzhur (LCN 18/7668) an HT consumer under Electrical Circle Irinjalakkuda has outstanding arrears as on 15.03.2021 (including interest) towards current charges from 09/2016 to 02/2018 amounting to ₹ 12,98,022/-. The service connection was disconnected on 28.10.2016 as per Consumer's request dated 24.10.2016. Due to default in payment of current charge with effect from 10/2016, the service connection was dismantled on 24.10.2017 as per rule.

The Revenue Recovery action was initiated against the consumer for realizing the arrears through the District Collector Thrissur on 05/06/2018. The Revenue Recovery action is still pending before the District Collector, Thrissur.

Now the consumer as per letter read as 2nd above, has requested for OTS Scheme 2021 sanctioned as per order read as 1st above.

The matter was placed before the Full Time Directors as per note read 3<sup>rd</sup> above.

Having considered the matter in detail, the Full Time Directors, in its meeting held on 31.03.2021 resolved to permit the consumer M/s. High-Tech Feed Mixing Plant, (KEPCO), Mala, KSPDC LTD, Kuzhur (LCN 18/7668) to clear the arrears under OTS Scheme 2021.

The decision to pass order as above was taken on 31.03.2021, which is during the currency of Model Code of Conduct (MCC) as ordered by the Election Commission of India. Orders has now been issued after lifting the Model Code of Conduct.
