## ORDER

M/s. Kaypee Metals & Alloys (P) Ltd. (Consumer Code HTB 6/3209) was a non-live HT consumer under Electrical Circle, Kottarakkara. The HT service connection in respect of the consumer was disconnected on 19.11.2018 and physically dismantled on 19.08.2019 due to default of current charges. The consumer has an outstanding arrear amounting to ₹ 8,47,48,739/- as on 31.03.2021 (including interest) towards current charges from the consumption month of 07/2017 to 08/2019.

The Revenue Recovery action was initiated against the consumer on 04.11.2019 for realizing the arrear amount though the District Collector, Kollam. The Revenue Recovery action is still pending in the Kollam Collectorate.

Now, the consumer as per letter read as 2<sup>nd</sup> above has requested for OTS Scheme sanctioned by KSEBL as per the order read as 1<sup>st</sup> above. Accordingly, the matter was placed before the Full Time Directors, KSEBL as per the note read as 3rd

The Full Time Directors in its meeting held on 31.03.2021 resolved to permit the consumer M/s. Kaypee Metals & Alloys Pvt. Ltd. to clear the arrears under OTS Scheme 2021.

The decision to pass order as above was taken on 31.03.2021, which is during the currency of Model Code of Conduct (MCC) as ordered by the Election Commission of India. Orders has now been issued after lifting the Model Code of Conduct.
