Having considered the matter in detail, the Full Time Directors in the meeting held on 30.04.2021 resolved to authorize the Executive Engineer, Transmission Division, Kazhakuttom to provide an Indemnity Bond in appropriate Stamp Paper (₹ 200/-) before the authorized officer as demanded by the Registration Department, Government of Kerala to indemnify at all times the indemnified from the liabilities that may be advanced against the indemnified

INDEMNITY BOND
