### Abstract

Settlement of current charge arrears of M/s. PNM Hospital (HTB.15/4222), Kattakkada, Thiruvananthapuram – Under OTS Scheme 2021 – Sanctioned – Orders issued.

### ORDER

M/s. PNM Hospital (HTB.15/4222) an HT consumer under Electrical Circle, Thiruvananthapuram (Rural) has an outstanding arrear as on 15.03.2021 (including interest) towards current charges from 06/2012 to 05/2014 amounting to ₹27,12,482/-. Due to the default of current charge, the service connection was disconnected on 21.11.2013 and dismantled on 18.08.2014 as per rules. The refundable amounts such as service connection charge and cash deposit were adjusted in the principal amount on 30.06.2014.

The Revenue Recovery action was initiated against the consumer for realizing the amount through the District Collector, Thiruvananthapuram. The consumer filed OP before the C.G.R.F (South), Kottarakkara against the Revenue Recovery action. The OP was disposed by the C.G.R.F as per order dated 27.02.2017 with a direction to extend the facility of OTS 2016 for settling the dues.

Complying with the order of the C.G.R.F (South), Kottarakkara, Kerala State Electricity Board Limited allowed One Time Settlement facility to the consumer for settlement. No remittance was made at that time. Later, the consumer remitted an amount of 4,83,245/- at the Kulathummil Village Office, Kattakkada.

Now the consumer as per letter read as 2<sup>nd</sup> above has requested for One Time Settlement scheme sanctioned by Kerala State Electricity Board Limited as per order read as 1<sup>st</sup> above. Accordingly the matter was placed before Full Time Directors of Kerala State Electricity Board Limited as per note read as 3<sup>rd</sup> above.

The Full Time Directors, in its meeting held on 31.03.2021 resolved to permit the consumer M/s. PNM Hospital, Kattakada (LCN 15/4222) to clear the arrears under OTS scheme 2021.

The decision to pass orders as above was taken on 31.03.2021, which is during the currency of Model Code of Conduct (MCC) as ordered by the Election Commission of India. Orders has now been issued after lifting the MCC.
