### ORDER

M/s. Ponmudi Paper Mills (P) Ltd. (Consumer Code HTB 15/1953), an HT consumer under Electrical Circle, Kattakkada, Thiruvananthapuram (Rural) has outstanding arrears as on 22.03.2021 (including interest) towards current charges from 03/2001 to 10/2009 amounting to ₹ 1,01,13,951/-. Due to the default of current charge, the service connection was disconnected on 06.04.2009 as per rule.

The Revenue Recovery action was initiated against the consumer for realizing the arrear amount through the District Collector, Thiruvananthapuram. The Revenue Recovery action is still pending in the Thiruvananthapuram Collectorate.

Now, the consumer as per letter read as 2<sup>nd</sup> above has requested for OTS Scheme sanctioned by KSEBL as per order read as 1<sup>st</sup> above. Accordingly, the matter was placed before the Full Time Directors, KSEBL as per note read as 3<sup>rd</sup> above.

The Full Time Directors in its meeting held on 31.03.2021 resolved to permit the consumer M/s. Ponmudi Paper Mills (P) Ltd. (LCN 15/1953) to clear the arrears under OTS Scheme 2021.

The decision to pass order as above was taken on 31.03.2021, which is during the currency of Model Code of Conduct (MCC) as ordered by the Election Commission of India. Orders has now been issued after lifting the Model Code of Conduct.
