## **ABSTRACT**

## **ORDER**

The tender for transportation contract is being invited from the office of the Chief Engineer(SCM) as a single tender for the entire state for the past so many years since three Fabrication Units started operation. The whole work of Transportation Contract is being arranged by the Executive Engineer, B&S Division Angamaly and transportation of all line materials to different locations of the state are being carried out by this single contractor.

The Chief Engineer(SCM) had obtained remarks from the Deputy Chief Engineer & Principal Team Leader, Civil Circle, Pallom and it was remarked that the availability of vehicles can be ensured in each Unit resulting in speedy delivery of materials if the tender for transportation contract is invited separately. It was also remarked that the rate in contract may increase since the quantum of work will be less compared to total quantity of the three manufacturing Units.

The Chief Engineer (SCM) had submitted a proposal as per the note read above before the Full Time Directors recommending that the next transportation contract shall be invited as three separate tenders by the Executive Engineers of each Manufacturing Units of KSEBL as per their delegation of power in such a way that new contract for transportation shall come into force within six months just after the expiry of extended period of contract of the existing transportation contract.(ie. From 03.11.2021 onwards)

Having examined all aspects in detail, the Full Time Directors meeting held on 30.04.2021 resolved to authorize the Executive Engineers of the three Manufacturing Units of KSEBL viz .Central Mechanical Facility- Pallom, Manufacturing Unit 1- Angamaly and Manufacturing Unit 2- Kolathara to invite the next tender for transportation contract as three separate tenders for each Manufacturing Units.

Orders are issued accordingly.
