ORDER

As per BO read as 1st above, sanction was accorded for incurring an expenditure of Rs.50,000/- in connection with the inauguration of new Division Office building, Inspection Bungalow and Dam Monitoring Server Centre at Vazhathope. The buildings were inaugurated by the Hon'ble Minister for Electricity on 26.01.2021 in the presence of several dignitaries and senior officials of KSEBL observing Covid-Protocol.

The Chief Engineer(C- DS&DRIP) as per note read as 2nd above has reported that even though sincere efforts were made to curtail and restrict the expenditure within the sanctioned amount, the expenditure crossed the above limit. The reasons were also explained and requested sanction for the additional expenditure of Rs.38,300/- incurred in connection with the inaugural function.

The matter was placed before the Full Time Directors as per note read as 3rd above. Having considered the matter in detail, the Full Time Directors in the meeting held on 23.04.2021 resolved to accord sanction for the additional expenditure of Rs.38,300/-over and above Rs.50,000/- already sanctioned vide BO read as 1st above totalling to Rs. 88,300/- incurred in connection with the inaugural function of new Division Office building, Inspection Bungalow and Dam Monitoring Server Centre at Vazhathope which was held on 26.01.2021.

The Full Time Directors observed that spending in excess of the sanctioned amount is not in order. Hence it is strictly directed that in future, expenditure shall be limited within the sanctioned amount.

Orders are issued accordingly.
