ORDER

M/s Reliance Jio Infocomm Limited obtained Right of Way(RoW) permission to draw cables through 3844.20 km run of roads throughout the Kerala State as per G.O.read as 1st above . The Chief Engineer(C- DS&DRIP) as per note read as 2nd above has reported that M/s. Jio Digital Fiber Private Limited have merged with M/s Reliance Jio Infocomm Limited and they have requested to grant permission to lay Optical Fiber Cable (OFC) in KSEBL road at Kulamavu dam for a length of 385m.

It is also reported that the Kerala Dam Safety Authority visited the site on 12.03.2021 and recommended to give permissive sanction to lay Optical Fiber Cable with the condition that cutting of dam top surface shall not be permitted, cable shall be drawn through standard conduits with proper clamping along the parapet of the dam without causing any inconvenience to the dam operation, vehicular traffic and disturbance to the the existing cables.

The Chief Engineer(C-DS&DRIP) has requested to issue permissive sanction to M/s Reliance Jio Infocomm Limited for laying Optical Fiber Cable in KSEBL road at Kulamavu and over Kulamavu dam for a length of 385m subject to conditions mentined therein.

The matter was placed before the Full Time Directors as per note read as 3rd above. Having considered the matter in detail, the Full Time Directors in the meeting held on 16.04.2021 resolved to accord sanction to the Chief Engineer(C-DS&DRIP) to give permission to M/s Reliance Jio Infocomm Limited for laying Optical Fiber Cable in KSEBL road at Kulamavu and over Kulamavu dam for a length of 385m as per standards and guidelines in the light of the G.O. (Ms) No. 28/2018 / ITD dated 17.11.2018 and subject to the following conditions:

1. The safety of the dam should not be affected in anyway.
2. Cutting of dam top surface shall not be permitted.
3. The cable shall be laid through standard conduits with proper clamping along the parapet of dam without causing inconvenience to the dam operation, vehicular traffic and disturbance to the the existing cables.
4. After laying of the OFC the excavated portion of the trench in the approach road to the dam should be backfilled, compacted and restored to its original surface.

5. An agreement shall be executed between the Executive Engineer, R&DS Division, Vazhathope and M/s Jio Digital Fibre Pvt Ltd. prior to the work to ensure compliance of the stipulation.

The Chief Engineer (Civil –Dam Safety & DRIP) shall take further action in this regard. Orders are issued accordingly.
