KSEBL as per Order read as 1st above, has accorded sanction to procure 7 Laptops for an approximate cost of Rs.4,00,000.00 (Rupees Four lakhs only) for the use of IT wing, Vydyuthi Bhavanam, Thiruvananthapuram and has also authorized the Chief Engineer(IT,CR&CAPs) to arrange the procurement of Laptop. Accordingly purchase order was issued to M/s.LR Infotech Systems, Thiruvananthapuram with an amount of Rs.3,86,500.00 for 07 nos Laptops.

In view of the above the Chief Engineer(IT,CR&CAPs) requested sanction to provide a Laptop for the use of Executive Engineer(CAPs), Vydyuthi Bhavanam, Thiruvananthapuram for an approximate cost of Rs.53,000.00 (Rupees Fifty three thousand only) and to authorize the Chief Engineer (IT,CR& CAPs) for giving additional order to the Purchase order read 2 above for procuring the same.

Having considered the matter in detail, the Full Time Directors in its meeting held on 08.04.2021,

Resolved to accord sanction to procure a Laptop for the use of Executive Engineer(CAPs), Vydyuthi Bhavanam, Thiruvananthapuram for an approximate cost of Rs.53,000.00 (Rupees fifty three thousand only).

Further resolved to authorize the Chief Engineer (IT,CR & CAPs) to give additional order to the Purchase order issued vide PO No.40/2020-21 dated 17.12.2020 for procuring the same.
