### ORDER

The Chathankottunada-II SHEP was dedicated to the nation on 20-02-2021. The Chief Engineer (Generation & PED) as per Note read as 3<sup>rd</sup> above has reported that for proper functioning of the power house, skilled staff shall be employed for operation and maintenance.

Accordingly, the Chief Engineer has recommended the following staff pattern for the smooth functioning of the power house and requested sanction for the same.

It is reported that presently the erection activities of the project is being handled by the Assistant Engineer - II (Erection sub Division, Kakkayam) and after completing the erection works, this place can be re designated as Station Engineer, Chathankottunada-II SHEP under Generation Sub Division, Kozhikode.

The matter was placed before the Full Time Directors as per Note read as 5<sup>th</sup> above. Having considered the matter in detail, the Full Time Directors in the meeting held on 16-04-2021 resolved to accord sanction to the Chief Engineer (Generation & PED) to arrange the operation of Chathankottunada-II SHEP on work contract basis complying CEA regulations.

Further resolved to accord sanction to the Chief Engineer (HRM) to fill up the posts of Maintenance staff, Sub Engineer (Ele.)(Diploma) (1 No.) and Electricity Worker (ITI) (2Nos.) by suitable shifting of post and that till the shifting is completed, the Chief Engineer (Generation & PED) shall engage suitable candidates on work contract basis.

Further resolved to re-designate the place of Assistant Engineer II, Erection Sub Division, Kakkayam as Station Engineer, Chathankottunada-II SHEP, on completion of the ongoing erection works of the Project.
