## ORDER

KSEBL as per LoA read as 1<sup>st</sup> above has given an EPC Contract to M/s Bosch Ltd Bangalore for installing 1MWp solar photovoltaic plant at Kanjikkode and its O&M is for 5 years from the date of commissioning. The plant was synchronized to grid on 10.08.2015 and has completed the 5<sup>th</sup> year after commissioning on 09.08.2020.

The O&M of the plant at the site is being continued by the existing contractor M/s Bosch Ltd and they had requested for the payment of the O&M during the period from and after 10.08.2020.

In light of the above, a detailed note read as 2<sup>nd</sup> above was placed by Chief Engineer (REES) before the Full time Directors for approval for allocating necessary funds for the extended O&M period upto 09.08.2021 and releasing the proportionate monthly payment to M/s Bosch Ltd Bangalore.

Having considered the matter in detail, the Full Time Directors in the meeting held on 08.04.2021 resolved to accord sanction for an amount of Rs. 8,80,000/- with applicable GST for the yearly Operation and Maintenance charges of the 1MWp solar plant installed at Kanjikkode for the period from 10.08.2020 to 09.08.2021.
