### **ORDER**

The Chief Engineer (Civil -Dam Safety & DRIP) as per letter read as 1<sup>st</sup> above has reported that the department vehicle (Bolero-bearing Reg No.KL-05-AN-6170 ) attached to the Dam Safety Section, Poringalkuthu had run an excess kilometre of 1945 over the sanctioned limit of 1500km (total 3445km run during the month of November 2020) and requested sanction for the additional kilometre run by the vehicle. It is also reported that one Sub Engineer of Poringalkuthu Sub Division was deputed to supervise the hydrographic survey works of Kallarkutty, Pambala, Maduppetty, Ponmudi and Anayirankal reservoirs and the vehicle was used for trips in connection with the above works. The total distance travelled for the survey purpose alone is 2671km.

The matter was placed before the Full Time Directors as per note read as 2<sup>nd</sup> above. Having considered the matter in detail, the Full Time Directors in the meeting held on 25.02.2021 resolved to accord sanction for the excess kilometre of 1945 km over the sanctioned limit of 1500km run by the department vehicle (Bolero-bearing Reg No.KL-05-AN-6170 ) attached to Dam Safety Section, Poringalkuthu as recommended by Chief Engineer (Civil -Dam Safety & DRIP)
