ORDER

E-tender was invited for Hot dip galvanization of 6500 MT of 'A' poles, of various lengths fabricated at the Mechanical Facilities of KSEB Ltd. for the year 2020-21 vide e-Tender No. CECCS/02/2020-21 dated 21.07.2020 by the Chief Engineer (Civil Construction) South. Three bidders submitted their offer and two of them pre-qualified for the subject work. The lowest quoted amount was 58.78 % above estimated PAC. On finding the quoted price as very high while comparing with the estimated PAC, KSEBL as per order read as 1st above decided to retender the work

As per G.O. read as 3rd above Government have revised the rates of Performance Security Deposit and Bid Security for the execution of public works in the State as relaxations on account of COVID-19 pandemic.

The Chief Engineer (Civil –Construction) South as per note read as 2nd above has requested sanction to modify the **Qualification Criteria for Technical Capability** to increase participation of bidders and requested sanction to invite retender for the subject work with revised PAC incorporating the revised tender conditions for qualification criteria for technical capability and the relaxed conditions as per the G.O read above.

The matter was placed as per the note dated 19.01.2021 above before the Full Time Directors on 20.01.2021. Having considered the matter, the Full Time Directors of KSEBL **Resolved** to accord sanction to

1. invite retender for the "Hot dip galvanization of 6500MT "A" Poles of various lengths fabricated at the Mechanical Facilities of KSEB Ltd. for the year 2020-21" with revised PAC incorporating the revised tender conditions for qualification criteria for technical capability

2. Further resolved to incorporate the relaxed conditions vide G.O.(P)No.7/2021/FIN dated Thiruvananthapuram 07.01.2021 in the tender condition

3. Further resolved to place the matter before the Board of Directors of KSEBL for ratification.

Accordingly, Board Order read as 4 above was issued in this regard. The matter is discussed in detail in the meeting of the Board of Directors held on 17.03.2021 and Resolved To ratify the action of Full Time Directors vide B.O(FTD) No 47 /2021 (DGC/AEE VI/Galv /2014) dated 21.01.2021 in having accorded sanction to invite retender for the "Hot dip galvanization of 6500MT "A" Poles of various lengths fabricated at the Mechanical Facilities of KSEB Ltd. for the year 2020-21" with revised PAC incorporating the revised tender conditions for qualification criteria for technical capability and to incorporate the relaxed conditions, vide G.O.(P)No.7/2021/FIN dated Thiruvananthapuram 07.01.2021 in the tender condition
