ABSTRACT

Cutting and removal of 36 nos. trees standing in the proposed site for 220/110kV GIS Substation, Pathanamthitta -Tender cum Auction confirmation at 25.53% of assessed value - Sanctioned - orders issued.

ORDER

The Administrative Sanction was accorded as per BO read 1st above, for the construction of 220/110kV SCADA enabled GIS Substation at Pathanamthitta and Kakkad and associated 220/110kV line using narrow base MCMV Towers, under the Sabari lines and substation package as part of TransGrid 2.0, phase 1 project.

The Chief Engineer, TransGrid has reported as per letter read 2nd above that, 36 Nos. of trees standing in the proposed site for the construction of 220/110kV GIS Substation, Pathanamthitta (which is behind Vydyuthi Bhavanam Pathanamthitta) are need to be cut and removed so as to start the construction work immediately. The construction of Transmission line to the proposed substation has already been awarded on turnkey basis and is scheduled to be completed by January 2022.

The valuation of trees had been done by the Assistant Conservator of Forest, social Forestry, Pathanamthitta and the survey report was prepared based on this valuation. The survey Report was sanctioned by the Chief Engineer, TransGrid for 36 Nos of trees with an assessed value of Rs.2,34,995/-.

The Deputy Chief Engineer, TransGrid South Kalamassery had conducted Tender cum auction two times after giving wide publicity for cutting and removing of the trees. In the first time no one participated in the tender cum auction. In the second time two tender forms are received and the highest bidder is Sri. Joseph Daniel, Vettukalayil Jomi Bhavanam, Paranthal P.O, Pandalam, Pathanamthitta at his quoted amount of amount is Rs.60,000/- which is 25.53 % of the assessed

The Chief Engineer, TransGrid, Kalamassery has requested sanction to confirm the auction at 25.53% of assessed value infavour of Sri. Joseph Daniel, Vettukalayil Jomi Bhavanam, Paranthal P.O, Pandalam, Pathanamthitta at his quoted amount of Rs.60,000/- (Rupees Sixty thousand only) + GST + Forest Development charges + Income Tax on Timber.

The matter is placed before the Full Time Directors as per note read as 3rd above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 23.03.2021, Resolved to accord sanction to confirm the Tender cum Auction conducted for the disposal of 36 Nos trees standing in the proposed land for the construction of 110/220kV GIS Substation Pathanamthitta behind Vidyuthi Bhavanam Pathanamthitta at 25.53 % of the assessed value with eligible taxes and duties in favour of Sri. Joseph Daniel, Vettukalayil Jomi Bhavanam, Paranthal P.O, Pandalam, Pathanamthitta which amounts to Rs.60,000/- (Rupees Sixty thousand only) + GST + Forest Development charges + Income Tax on Timber.

Orders are issued accordingly.
