ORDER

The Chief Engineer (Generation &PED) has reported that the execution of balance E&M works of Pallivasal Extension Scheme (2x30MW) has been awarded to M/s. TVPPL-KSK-REHPL-DEC Consortium as per Work Order read as 1st above and the period of completion of the work is 8 months from the date of LoA, which was issued on 11-01-2021. It is reported that the work has already been started based on LoA. M/s. Dongfang Electric Corporation (DEC), who was OEM and a partner of the consortium to whom the original contract was awarded is a Consortium partner of the contractor for this contract also. The supplied materials, panels, equipment, devices and systems have been kept idle in KSEBL stores for the past several years due to reasons beyond control of KSEBL. Certain items may need replacement and this requirement has already been addressed in the contract document. In all such cases, revised drawings and design are to be finalized and corresponding approvals are to be issued. The technical feasibility in such cases has to be examined and finalized by KSEBL after incorporating revision, if any, needed. These activities are to be streamlined in a time bound manner for which formation of a technical committee comprising of experienced engineers will be much helpful in arriving at fast decisions. The area of expertise needed ranges from Mechanical, hydraulic, Electrical, Control System, SCADA, Generator, Water Conducting System etc.

The Chief Engineer (Generation &PED) has recommended to form a Technical Advisory Committee with seven members, including Sri. Jose Mathew, Deputy Chief Engineer (Retired), Generation Circle, Meencut who has attended the Factory Acceptance Tests for PES at M/s. Dongfang Electric Corporation (DEC), China and having vast experience in the field of erection, operation and maintenance of various power stations in the KSEBL. It is reported that his service for technical support and supervision for this project is inevitable to complete the project by using the machines supplied by the old contractor. It is also proposed to allow remuneration to Sri. Jose Mathew (Rs.10,000/- per day limited to 6 days in a month) for its functioning. Sanction was also requested for constituting the Committee with the following structure.
