ORDER

Several requests and proposals have been received from the elected representatives, LSG Institutions and general public for bifurcating the existing Electrical Sections or for creation of new Sections extracting certain areas / consumers from some of the adjoining Electrical Sections or to start new Sub Engineer Offices/ Overseer offices to effectively handle the supply failure issues within the time frames fixed as per Standards of Performance published by the Hon'ble KSERC. The service expectancy of the consumers also has increased and it is often found difficult to cater to consumer requirements if the Section offices have very high consumer strength and / or vast area.

Having examined the matter in detail, considering the vast area, terrain, difficulty in maintaining electrical infrastructure and resolving interruption issues, the Director (Distribution, IT and HRM) proposed to form sub Centres under 11 Electrical Sections. At these sub centres, a Breakdown Unit will function in a building to be provided by the concerned local body, free of rent with vehicle and CUG facility to resolve the prolonged power interruption issues. The matter was placed for decision as per note read as 5th above, and the Chairman and Managing Director agreed upon the same on 06.02.2021 with the direction to issue office order and to place the same before the Full Time Directors for ratification.

Accordingly, Office Order read as 6th above, was issued for the functioning of Sub Centres, in buildings provided free of rent by the concerned local bodies, with vehicle and CUG facility to resolve the prolonged power interruption issues under 11 Electrical Sections.

The matter was placed before the Full Time Directors as per note read as 7th above for ratification. Having considered the matter in detail, the Full Time Directors of the Board in its meeting held on 25.02.2021, resolved to ratify the issuance of the Office Order No. 179/2021 [D(D&IT)/D6-AE2/New Office/2020-21/0001] dated 06.02.2021 for the formation of new Sub Centres attached to Electrical Section Offices.
