ORDER

As per the letter read above the Chief Engineer (Distribution North), Kozhikode has reported that tender cum auction was conducted three times for the sale of six trees in the proposed site for the construction of Mini Vydyuthi Bhavanam, Pattambi in the compound of 33kV Substation, Pattambi. The value assessed for the trees by the Social Forestry Division, Palakkad is ₹51,913/-. As nobody participated in these tender cum auction, re-auction was conducted for the fourth time. Three persons participated in the auction and the highest rate of ₹20,000/- was offered by Sri. V T Kammed, Vayambathodi (H), Marathur P Q, Pattambi, Palakkad.

The Deputy Chief Engineer, Electrical Circle, Shoranur has reported that there is no chance of getting any higher value on re-tendering. Further, the removal of trees are necessary and inevitable for the ongoing construction activities in the location.

In the circumstances, the Chief Engineer (Distribution North), Kozhikode has requested sanction to accept the offered rate of ₹20,000/- quoted by Sri. V T Kammed, Vayambathodi (H), Marathur P O, Pattambi, Palakkad in the re-auction conducted for disposal of six trees in the proposed site for the Mini Vydyuthi Bhavanam, Pattambi for carrying out the construction activities.

The matter was placed before the Full Time Directors as per the note read as 2nd above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 09/03/2021, resolved to accord sanction for accepting the rate offered in the re-auction conducted for disposal of six trees in the proposed site for Mini Vydyuthi Bhavanam, Pattambi for carrying out the construction activities of Vydyuthi Bhavanam, Pattambi at the highest rate of ₹20,000/- offered by Sri.V.T. Kammed, Vayambathodi (H), Marathur P O, Pattambi, Palakkad.

Orders are issued accordingly.
