ORDER

The Deputy Chief Engineer, Electrical Circle, Nilambur as per letter read as 1st above has reported that power supply to the consumers of Mathil Moola Colony and related places under Electrical Section Akambadam was disrupted due to the flood in August 2018 and then restored by reconstructing lines and replacing poles etc. Then again the floods in August 2019 completely destroyed the posts and lines in the same areas. The power supply has not yet been restored there as the river changed its course and flooded the area, destroying the route, filling it with mud and rocks. Taking into account the threat of further floods, the relatively unsafe conditions for drawing electric lines and the undergoing measures to evacuate the colony residents to Kannamkand area, the power supply has not yet been restored.

The consumers are being charged a minimum bill since 2019 August in the 'Orumanet' connected status but the bills were not being served to the consumers from August 2019 onwards.

Arrear status for the 18 consumers as on 03.10.2020 is Rs 6495/- (Rupees Six thousand four hundred and ninety five) only. It was requested to accord orders to the effect that the electricity connection of 18 consumers in that area should be dismantled and their electricity arrears should be waived.

The matter was placed before the Full Time Directors as per note read 2 above.

Having examined the matter in detail, the Full Time Directors in the meeting held on

Nilambur to dismantle the electricity connections of 18 consumers in the area of Mathil Moola Colony and related places following the flood at August 2018 under Electrical Section Akambadam and to waive their current charge arrears.

Orders are issued accordingly.
