ORDER

The Chathankottunada SHEP stage II (2MW X3) is a run off the river scheme in Kuttiadi river basin in Kozhikode District. This scheme envisages utilization of the inflow from two streams viz. Poothampara and Karingad and the expected annual generation is 14.76 MU. The work of Chathankottunada SHEP stage II (2MW X3) was awarded to M/s K.K. Builders, Civil Engineering Contractors, Peravoor, Kannur and inaugural function was held on 20.02.2021 by the Hon'ble Minister for Electricity Sri.M.M.Mani at the Power House premises of the scheme

The Chief Engineer (Civil Construction) North as per letter read as 1st above has reported that some complaints/ requests of local residents, have been received and more requests are likely to come as the project is nearing completion which are pending for decision. The petitioners include Smt. Leela Valayamkottummam and Anitha Valayamkottummam, demanded new plot and house at KSEBL's expense, Sri. Ayub and five others, requested to construct a bridge to cross the channel to his plot of 2.35 acre, Sri Chandran , Convenor Valayakode Road Protection Committee, requested a bridge across the power channel to access their plots etc.

The Chief Engineer (CC) North requested sanction to constitute a committee, having members drawn from KSEBL, Panchayath, representatives of Revenue Department, Engineer of LSGD. to examine the genuineness of the above complaints/ requests and to give suitable recommendation.

The matter was placed before the Chairman & Managing Director as per note read as 2nd above, and sanction was accorded to constitute the committee, having members from KSEBL, Panchayath, Revenue Department and LSGD as furnished by the Chief Engineer as follows.
