## ORDER

Smt Asha, SK Bhavan, Krishnapuram, a consumer under Electrical Section, Vamanapuram intimated as per letter read as 1<sup>st</sup> above that she is in receipt of a notice from KSEBL asking her to remit the OYEC arrears of ₹ 7933/- failing which her supply would be disconnected and requested to waive her arrears. She also intimated that she has a handicapped child and her husband who is a labourer is out of job due to the pandemic.

The Assistant Executive Engineer, Electrical Subdivision, Venjarammood reported that the service connection having consumer No.22754 under Electrical Section, Venjarammood was availed by Smt Asha on 07.01.2012 on ECSC installment scheme and that later the service connection got immigrated to Electrical Section, Vamanapuram with consumer No.13560. Out of the Total ECSC amount of ₹12,800/-, the consumer has remitted an amount of ₹5238/. The outstanding amount including the interest of ₹371 is ₹7933/-.

The Executive Engineer, Electrical Division, Nedumangad reported that the petitioner belongs to the BPL and SC category and that the petitioner has a connected load below 1000 Watts. The Executive Engineer requested orders for waiving the balance amount.

The matter of waiving the balance OYEC installment arrears of Smt Asha, Consumer № 13560, under Electrical Section, Vamanapuram, amounting to ₹ 7933/-, was placed before the Full time Directors as per note read as 4<sup>th</sup> above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 25/02/2021, resolved to accord sanction to waive the OYEC installment arrears of ₹7933/pending against the consumer Smt Asha, Consumer No. 13560 under Electrical Section, Vamanapuram, considering that the consumer belongs to the BPL category and the connected load is less than 1000 watts and considering that the consumer has a child with 40% disability, as a special case.

Orders are issued accordingly.
