ORDER

The office of the Director (Distribution) has been taking steps for regularization of unauthorized cable drawal along the electric poles of KSEBL and for settling of long pending pole rental arrears by granting One Time Settlement (OTS) facility and by conducting Adalaths. As per B.O. read as 4th above, OTS facility was granted for settling the pole rental arrears for more than 2 years, as on 31.03.2019. As per Office Order read as 6th above, sanction has been accorded to include Cable TV Operators with pole rental arrears for more than two years also under the One Time Settlement Scheme with similar terms and conditions of OTS-2019 Scheme sanctioned as per B.O. read as 5th above. Again, during

the Janakeeya Adalath conducted during January/February, 2020, reduction of interests and installments (maximum 12 installments for the principal amount) were allowed to settle pole rental arrears of Cable TV Operators as per OTS-2019 Scheme. For regularizing unauthorized cable drawal during the period from 09/2015, directions were issued as per B.O read as 3rd above. Again as per B.O. read as 8th above, the Deputy Chief Engineers of Electrical Circles were authorized to regularize the unauthorized drawal of cables along the electric poles of KSEBL.

The Deputy Chief Engineer, Electrical Circle, Kozhikode had conducted meeting of all the Cable TV Operators at Sub Division Level under the Circle and the operators raised some concerns including the accumulation of huge amount due to financial constraints, change in ownership due to the stoppage of previous operators, difficulties arised due to mandatory approval from the Electrical Inspectorate etc.

As the issue of non- realization of pole rent from Cable TV Operators remains unresolved for long time, even after many efforts, the Deputy Chief Engineer, Electrical Circle, Kozhikode has suggested some methodology for consideration:

The Chief Engineer, Distribution(Central) as per letter read as 11th above has reported that the Executive Engineer, Electrical Division, Harippad has taken positive steps to clear the old pole rent arrears. About 80% of the Operators responded, but they are unwilling to pay the dues as they have objection in the way of preparation of the demand. The Executive Engineer, Electrical Division, Harippad has also suggested some solutions to reduce the demand amicable to the Operators.

Considering the two recommendations, the matter is placed before the Full Time Directors for authorising the Deputy Chief Engineers of Electrical Circles to constitute Circle level Committees for settling the long pending cases of pole rental arrears of Cable TV Operators/ Others under Electrical Divisions on account of cable drawal along electric poles of KSEBL, with the Deputy Chief Engineer of the respective Circle as Chairperson and the following Committee members.

Executive Engineers of respective Electrical Divisions – Members

Divisional Accountants of the respective Electrical Divisions- Members

An Officer from the respective Regional Audit Office

Other members as proposed by the Deputy Chief Engineer

The Committee may analyse the matter on case to case basis for clearing the pole rental arrears in line with the recent Adalath and OTS guidelines, conducting personal hearings wherever required. All the pending cases may be settled at Circle level on or before 31.03.2021. Cases calling for policy decisions may be taken up with the Director (Distribution, IT & HRM).

Having examined the matter in detail, the Full Time Directors in the meeting held on 25.02.2021, resolved to authorise the Deputy Chief Engineers of Electrical Circles to constitute Circle level Committees for settling the long pending cases of pole rental arrears of Cable TV Operators/others under Electrical Divisions on account of cable drawal along electric poles of KSEBL, with with the Deputy Chief Engineer of the respective Circle as Chairperson and the following Committee members.

- 1. Executive Engineers of respective Electrical Divisions Members
- 2. Divisional Accountants of the respective Electrical Divisions- Members
- 3. An Officer from the respective Regional Audit Office.
- 4. Other members as proposed by the Deputy Chief Engineer.

Further resolved that the Committee may analyse the matter on case to case basis for clearing the pole rental arrears in line with the recent Adalath and OTS guidelines, conducting personal hearings wherever required. All the pending cases may be settled at Circle level on or before 31.03.2021. Cases calling for policy decisions may be taken up with the Director (Distribution, IT & HRM).

Orders are issued accordingly.
