ORDER

Smt.Rajitha.K ,Ittiyampara under Electrical Section, Chakkittapara, Kozhikode, in her application addressed to the Hon'ble Minister for Electricity, read as 2nd above, has requested to help her in shifting of the LT OH line that passes over the site of the proposed new house, considering her poor financial situation. The applicant has stated that she has been granted sanction for constructing a house in her property under "Life Mission Housing Scheme" of the Government, but the construction of the building could not be commenced because of the LT line passing across this property.

The Deputy Chief Engineer, Electrical Circle, Vadakara has furnished a detailed estimate amounting to Rs 11,178/- (material and labour) for realignment of the existing LT line to the side of the purampoke land, under Electrical Section, Chakkittapara. The applicant belongs to BPL Category and has furnished proof of the same. The length of the existing LT 1 phase, OH line is 38 m , while that of the proposed new route (to the side of the purampoke land) will be increased by 7 m and would necessitate erection of one additional LT pole along with stay for suitable realignment of the LT line , for facilitating construction of the house.

As per the BO read as 1st above, "For applicants under BPL/SC/ST category, if electric line/posts are situated obstructing construction of house under "Life Mission Housing Scheme", for shifting the line to any other portion of the land or along public path, to bear full cost of shifting by the Board if shifting is technically feasible."

In this case, applicant belongs to BPL and construction of house under "Life Mission Housing Scheme" for which the applicant has sought exemption.

The matter was placed before Full Time Directors as per note read as 4th above. Having examined the matter in detail, the Full Time Directors in the meeting held on 25.02.2021 resolved to accord sanction to the Deputy Chief Engineer, Electrical Circle, Vadakara to carry out the work of "Shifting of LT OH line passing above the site of the proposed new house of Smt. Rajitha.K,Ittiyampara under Electrical Section, Chakkittapara to the side of the purampoke land near to her property" using Board's fund, considering the poor financial condition of the beneficiary, as a special case.

Orders are issued accordingly.
