ORDER

Two part tenders were invited for the supply of 465 Km of 11kV 3x300 mm² Dry Cured Aluminium Conductor XLPE UG Cable on variable price basis, as per Bid. No. SCM/eP.38/2020-21 dated 08/07/2020 with Probable Amount of Contract amounting to Rs. 62.38 Crore to meet the requirement under Purchase Plan 2020-21. Fourteen firms had submitted their offers.

The bid documents are evaluated for the conformity of the technical and commercial requirements of KSEBL and thereafter financial remarks of the Financial Advisor has been obtained.

Then the Pre-Qualification Committee held on 20/01/2021 decided to pre qualify the following 9 firms who satisfies the technical and commercial requirements and disqualified 5 firms not meeting the technical and commercial requirements

- i) M/s.Apar Industries Limited, Mumbai
- ii) M/s.Gemscab Industries Limited, Rajasthan
- iii) M/s.Havells India Limited, Noida
- iv) M/s.KEI Industries Limited, New Delh
- v)M/s. Paramount Communications Limited,New Delhi
- vi) M/s. Universal Cables Limited,Satna, M.P.

vii) M/s. LS Cable India Pvt. Limited, Rewari

viii) M/s.Tirupati Plastomatics Private Limited, Rajasthan

ix) M/s. SBEE Cables (India) Limited, New Delhi (New Entrant)

The price bid of the pre-qualified bidders were opened on 22/01/2021.

M/s.Apar Industries Limited has quoted the lowest all inclusive rate (L1) of Rs.1092680.00 per km, further no reduction in price offered by the firm upon the negotiation. The L2 bidder M/s.KEI Industries Limited, has confirmed their willingness to match the all inclusive variable L1 rate of Rs.1092680.00/-quoted by the L1 bidder, M/s.Apar Industries Limited based on the post bid negotiation.

The Purchase Committee meeting held on 08/02/2021 decided to place the matter before the Board of Directors for a decision to place the purchase orders. Then the matter has been placed before the Board of Directors as per note read as 1st paper above.

Having examined the matter in detail, the Board of Directors in its meeting held on 15/02/2021 resolved to authorize the Chief Engineer (SCM) for the following

1. To place Purchase order for the supply of 325 km (70% of the tendered quantity) of 11kV 3x300mm² Dry Cured XLPE UG Cable with L1 bidder, M/s. Apar Industries Limited, Mumbai at an all inclusive variable rate of Rs.1092680.00 per km (Basic Price Rs 881900.00/-, Freight Rs. 44,100/- Transit cum one month storage charge Rs 0.00/-, 18% GST Rs.166680.00/-) for normal distribution works. The financial commitment will be Rs.35,51,21,000/-(Rupees Thirty Five Crore Fifty One Lakh Twenty One Thousand only).
2. To place Purchase order for the supply of 140 km (30% of the tendered quantity) of 11kV 3x300mm² Dry Cured XLPE UG Cable with L2 bidder, M/s.KEI Industries Limited, Mumbai at an all inclusive variable rate of Rs.1092680.00 per km (Basic Price Rs.873585.00.00/-, Freight Rs 52415/- Transit cum one month storage charge Rs 0.00, 18% GST Rs.166680.00/-) for normal distribution and transmission works.The financial commitment will be Rs.15,29,75,200/-(Rupees Fifteen Crore Twenty Nine Lakh Seventy Five Thousand Two Hundred only).

TCS as applicable shall be extra for both the orders.

The total financial commitment for the above supplies will be Rs.50,80,96,200/- (Rupees Fifty Crore Eighty Lakh Ninety Six Thousand Two Hundred only)
