ABSTRACT

Implementation of Enterprise Resource Planning (ERP) in KSEBL under Partial turnkey basis / departmental execution – Formation of Functional committees – Sanctioned – Orders issued.

ORDER

The Chief Engineer (IT, CR & CAPs) as per the note read above has reported that the Integrated Power Development Scheme (IPDS) has been launched by Ministry of Power, Government of India for continual up-gradation and creation of infrastructure of electricity distribution sector along with project formulation of ERP applications and M/s. Power Finance Corporation (PFC), has been entrusted as the nodal agency of the scheme. M/s. KPMG Advisory Service Private Limited was appointed as the Project Management Agency (PMA) based on the B.O. read as 1st above.

The Detailed Project Report (DPR) prepared (based on IPDS guidelines and based on PFC's standard template), for Rs. 42.64 Crore was sanctioned as per B.O. read as 2nd above and approved in the 11th meeting of IPDS monitoring committee held on 05.12.2017 having a grant component of Rs. 25.79 Crore with Partial Turn Key based execution mode.

Since no firms participated in the tendering process to identify an ERP Implementation Agency, even after re-tendering, as per B.O. read as 3rd above, KSEBL had accorded sanction to carry out customization / development and implementation of ERP solution with the in-house development team under IT wing, as part of Partial turnkey based execution sanctioned by PFC and supply, installation and commissioning of servers, storage etc. through open tender process.

As per the DPR approved by PFC, the implementation of ERP is proposed to cover Finance & Accounts, Supply Chain Management and Human Resource Management. PMA has completed preparation of essential documentation such as System Requirement Specification (SRS), High and Low Level Design documents (HLD & LLD), Data Flow Diagram (DFD) etc. The software development / customization for ERP system is also in the final stages of completion.

In view of the above, the Chief Engineer (IT, CR & CAPs) has suggested to constitute Functional Committees to evaluate that the functional requirements are taken care in the SRS document and to recommend necessary approvals for the proposed system and processes along with carrying out User Acceptance Testing (UAT) of the ERP solution.

Having considered the note read above, the FTD in the meeting held on 17.02.2021 decided to constitute the following Functional Committees for evaluation of functional requirements and UAT of the proposed ERP solution under IPDS in KSEBL:
