

## Abstract

Adoption of DSR 2018 and subsequent cancellation of the same by the Government- releasing retention amount - Sanction accorded- Orders issued.

## ORDER

The Chief Engineer(Generation & PED), as per letters read 4<sup>th</sup> above reported the issues aroused in connection with non-adoption of DSR-2018, in KSEBL and the difficulty in releasing the full retention amount, of the three works executed , under Generation Circle, Kothamangalam, even after satisfactory completion of the works.

The Government had accorded sanction to adopt DSR 2018 as per G.O. read 1<sup>st</sup> above, for the preparation of estimates from 01-04-2020 onwards. Later ,the implementation of the same was suspended vide Circular dated 21-05-2020 and G.O read 3<sup>rd</sup> above . During this period, the following works were tendered and executed under Generation Circle ,Kothamangalam with DSR 2018 .

From the table,it is evident that all the three works were tendered while DSR 2018 was in force in Government and the retention amount was calculated based on DSR-2018. But, the G.O read as 1<sup>st</sup> above and DSR 2018 has not been adopted in the KSEBL. So, the prevailing DSR applicable in Government and in KSEBL is DSR 2016 .In this scenario, the bills with DSR- 2018 could not be passed for the above works even after the execution of the works satisfactorily. Hence, it was decided to pass the bills pertaining to the above works with DSR 2016 and the balance amount kept as retention which could not be released .

As all the works were tendered while DSR 2018 was in force in Government and executed satisfactorily, the Chief Engineer(Generation & PED) Moolamattom has requested sanction for admitting DSR 2018 ,to the above works ,as a special case so that the balance retention amount may be released.

The matter was placed before the Full Time Directors as per note read as 5<sup>th</sup> above .Having considered the matter in detail, the Full Time Directors meeting held on 08-02-2021, resolved to apply DSR 2018 to the mentioned works as a special case, as the tenders were invited during the period of existence of the Government Order dated 22-12-2019.

Further resolved to accord sanction to the Chief Engineer (Generation &PED), Moolamattom, for releasing the balance retention amount.

Further resolved to issue a warning letter to the officers responsible to be careful in future.  
Orders are issued accordingly.
