ORDER

Setting up of six pilot Electric Vehicle Charging Stations were completed and as per Board Order read as 1st above, it was resolved to waive the charging fee to all customers for the first three months to promote Electric Vehicles in the State. Free charging is only up to 06.2.2021 and linking of online payment has already been taken up with M/s Mass-Tech Controls Pvt Ltd and KSEBL- IT wing

The Chief Engineer (REES) as per note read 2 above requested to extend the free charging period, citing one month trial period may be needed to identify and overcome the potential real time errors and difficulties while operating the payment mechanism before rolling out the online application to the public

The matter was placed before Full Time Directors as per note read 3 above. Having considered the matter, the Full Time Directors in its meeting held on 20.02.2021 resolved to accord sanction to allow one month extension for free charging to all customers in the six EV Charging Stations commissioned by KSEBL from 6.2.2021 to 6.3.2021 for the smooth roll out of payment application to the public.
