ORDER

The General Secretary, Kerala Football Association as per letter read above has informed that the Kerala Premier League Football Championship for the year 2021 will be held in March 2021. KSEB Football team has been invited to participate in the said Championship.

As per note read above the Sports Co-ordinator has reported that an amount of Rs.4,00,000/- (Rupees Four Lakh only) is estimated towards the total expenditure for participation of the KSEB Football team in the above Championship. The Sports Co-ordinator has also informed that M/s.Madre Integrated Engineering, Qatar has expressed their willingness to sponsor the KSEB Football team by allotting an amount of Rs.4,00,000/- (Rupees Four Lakh only) towards the expenses for participation in the Premier League Championship.

The Sports Co-ordinator as per note read above has recommended to grant permission to the KSEB Football team to participate in the Kerala Premier League Championship for the year 2021 and to accept the sponsorship offer of M/s.Madre Integrated Engineering, Qatar. Sanction is also sought for the payment of Rs.10,000/-* (Rupees Ten Thousand only) towards entry fee for participation in the above Championship.

Having considered the matter in detail, the Full Time Directors meeting held on 04-02-2021 resolved to accord sanction for the following.

- To permit the KSEB Football team to participate in the Kerala Premier League Football Championship as per the new format of Kerala Football Association.
- ii) To accept the offer of M/s.Madre Integrated Engineering, Qatar to sponsor the KSEB Football team for the above Championship for an amount of Rs.4,00,000/- (Rupees Four Lakh only).
