ORDER

M/s.KMRL is progressing with Phase II of the Metro alignment works. Now they have requested to increase the clearance of 66 kV EHT line crossing the proposed track Hence the Chief Engineer, Transmission South as per Note read as 1st above,has submitted a proposal for inserting 5 nos. towers in 3 feeders and dismantling 5 nos. existing towers for increasing the clearance of the EHT line crossing to the proposed track under deposit work.

The following works are included in the proposal.

The estimates are prepared based on transmission cost data dated 24.04.2019 and labour data for Transmission Line construction dated 13.04.2020 and civil data based on DSR 2016.

The Total estimate amount is Rs. 12,03,20,000/-

The work is envisaged to be executed with material supply and work both being carried out by KMRL under the supervision of KSEB Ltd. The supervision charges amounting to Rs. 1,09,37,052 and all other statutory expenses for the work are to be borne by M/s KMRL.

As per the Clause no. 8.1 of Delegation of powers of Executive officers dated 25.04.2017, the Full Time Director is authorised to grant administrative sanction to Deposit works > Rs. 5 Cr.

The matter was placed before the Full Time Directors as per note read as 2rd above .

Having considered the above, the Full Time Directors in the meeting held on 04.02.2021,

Resolved to accord Administrative Sanction for an amount of Rs. 12.032 Crore (Rupees Twelve Crore three lakh and twenty thousand) in favour of M/s KMRL under Transmission Circle, Kalamassery for inserting 5 nos. towers in 3 feeders and dismantling 5 nos. existing towers for increasing the clearance of the EHT line crossing to the proposed track of Phase II of the Metro alignment works under deposit work under Transmission Circle, Kalamassery, subject to condition that the supervision charges amounting to Rs. 1,09,37,052/- and all other statutory expenses for the work are to be borne by M/s KMRL.
