RECIPMT has offered a 3 Day Free Training Programme on "Electrical Safety" in Power Transmission and 3 Day Free Training Programme on "Electrical Safety" in Power Distribution. The programme will be conducted by RECIPMT free of cost to the Power Utilities to create awareness about safety Aspects in Power Transmission and Power Distribution. RECIPMT has allocated 4 batches of training 2 batches at Thiruvananthapuram and two batches at PETARC, Moolamattom. Each batch shall contain a maximum of 30 participants.

The Programme objectives are to create awareness on safety regulations and its latest amendments to ensure accident free system, Safety Code, Policy, Objectives action plan, safety committees and safety manual pertaining to transmission and distribution, broad discussion on earthing and bonding and lightning and surge protection in respect of transmission system, i.e EHT lines and substations including GIS and their role in preventing accidents, electric shock hazards and protection measures, familiarize participants with TAC regulations, fire protection systems and fire extinguishers etc, comprehensive study of causes of accidents, guidelines for prevention, accident reporting review and safety tools etc. The training is targeted for junior and middle level executives working in transmission and distribution sector.

The terms and conditions for conducting of 3 day free Training programme on "Electrical Safety" for Power Utilities sponsored by RECIPMT is as listed below.

- Venue/ Training Hall will be provided by the Utility. Utility has to arrange the classroom with all teaching Aids such as Computer System with Projector, Audio Visual equipment, slide changer, Public Address system etc.
- 2 RECIPMT will depute the faculties for the programme and if faculties are arranged by the Utility, all related cost such as Honorarium, travel, accommodation etc will be borne by RECIPMT as per approved budget.
- 3. Pick up and drop from Airport/Railway Station to place of stay and place of stay to training venue will have to be arranged by the utility.

4. Accommodation for faculties and participants is to be arranged by the Utility.

5. The Course Kit consists of a bag, reference / course material, scribbling pad pen, Certificates, certificate holder, Banner and Photograph etc has to be arranged by the KSEBL. All Invoices and Bills should be GST Invoice and should bear the name of RECIPMT. All expenses should be within Rs.900/- participant. The cost of Lunch and two time tea shall be within Rs.350/ participant/day inclusive of GST.

1. To conduct 3 days free training programme on "Electrical Safety" in Power Transmission and 3 days free training programme on "Electrical Safety" in Power Distribution sponsored by RECIPMT, Hyderabad at Thiruvananthapuram and

PETARC, Moolamattom as per the Terms and Conditions of RECIPMT as mentioned above and as per the convenience of the training facilitators.

2. To issue work assignment letter to the training facilitators, RECIPMT, Hyderabad

 To authorise the Chief Engineer (HRM) to conduct two batches of training at Thiruvananthapuram as per the convenient dates of both training facilitators and KSEBL completing all formalities and to make suitable changes for successful completion of program.

4. To authorise the Deputy Chief Engineer, PETARC, Moolamattom to conduct two batches of training at PETARC, Moolamattom as per the convenient dates of both training facilitator and KSEBL completing all formalities and to make suitable

changes for successful completion of programme.

5. To approve the estimate amounting to Rs. 81,000/- (Rupees Eighty One Thousand Only) for conducting both the trainings at Thiruvananthapuram.

6. To bear an amount of Rs.18,000/- (Cost of arranging training hall at EMC, Sreekariyam) by KSEBL and Rs.63,000/- shall be reimbursed by RECIPMT, Hyderabad.

To entrust the Chief Safety Commissioner, KSEBL to provide the list of 60
participants from Distribution side and 60 participants from the Transmission side
for attending the classroom session on Electrical Safety at Thiruvananthapuram and
PETARC.

8. To entrust the Secretary (Admn) to arrange vehicle at Thiruvananthapuram through VMC for 8 days after confirming the dates of the training by the Chief Engineer (HRM) and to arrange other items like printing of learning material, etc prior to the training by HRD Cell.

9. To authorize the Dy. Chief Engineer, HRM II to issue a temporary imprest amounting to Rs.81,000/-(Rupees Eighty One Thousand only) to Smt. Manjula P V, Assistant Executive Engineer, HRD Cell, O/o the Chief Engineer (FIRM) to meet the

training related expenses.

10. To meet the expenses amounting to Rs.18,000/- (Rupees Eighteen Thousand only) from the Budget allocation of Rs.600 lakhs earmarked for HRD activities under the Institutional Development Programme Fund for the year 2020-2021 (Amount booked under HRD and SRCTC)

11. To authorise the Deputy Chief Engineer (HRM II) to effect the payment and to remit balance Rs.63,000/- to the account of the KSEBL once it is refunded by RECIPMT, Hyderabad
