## ORDER

The IT Secretary, Government of Kerala, as per letter read as 1<sup>st</sup> above had intimated to make available, the services of one Chief Engineer, an Executive Engineer and two Assistant Executive Engineers to be provided in KSITIL to facilitate overall coordination of KFON project on deputation basis. KSEBL, as per order read as 2<sup>nd</sup> above has accorded sanction to authorize Director (Distribution & IT) to propose the list of officers for deputation to K-FON. Sanction was accorded for deputation of the following officers to KFON as per office order read as 3<sup>rd</sup> above with one Deputy Chief Engineer instead of a Chief Engineer.

The Government as per order read as 4<sup>th</sup> above appointed Sri. Moses Rajkumar S, Deputy Chief Engineer, KSEBL, to KSITIL on deputation basis, for looking the KFON project operation. Subsequently, KSITIL as per letter read as 5<sup>th</sup> above requested to depute a Chief Engineer rank personnel to KFON project in the place of Deputy Chief Engineer. KFON is a prestigious project of Government and presently the manpower allocation in KFON project from the SPV part is too less. KSITIL also requested that in addition to one Chief Engineer, KSEBL may depute one Executive Engineer and one Assistant Engineer level personnel to KSITIL for the execution of KFON project. In the prevailing KSITIL structure, only three deputations from KSEBL are possible to accommodate. Meanwhile, as per letters read as 6<sup>th</sup> and 7<sup>th</sup>, Smt. LEKHA.P , Exe. Engineer, LD Station, Kalamassery and Sri. SAM.S Asst. Engineer,110kV Substation, Balaramapuram have expressed their willingness to be deputed to KSITIL for KFON Project.

The matter was placed before the Full Time Directors as per note read as 8<sup>th</sup> above, regarding whether the above officers may be deputed to KSITIL for the implementation of KFON Project in addition to Sri. Moses Rajkumar S, Dy. Chief Engineer, already under deputation to KSITIL in the place of a Chief Engineer.

Having considered the matter in detail, the Full Time Directors, in the meeting held on 04.02.2021, resolved to accord sanction for the deputation of the following officers to KSITIL, for the implementation of KFON Project in addition to Sri. Moses Rajkumar S; Dy. Chief Engineer, already under deputation to KSITIL.
