ORDER

The Chief Engineer(IT, CR & CAPs) in the note read above has reported that Government of Kerala, under Capital Region Development Programme(CRDP-II) is preparing a Master Development Plan and land pooling policy for the Outer Area Growth Corridor(OAGC). M/s.LEA Associates in JV with DOHWA(Korea) and DPC are the consultants for this project. As a part of preparing the Master Plan, the consultant are in the process of collecting data from various Department and Authorities. In this connection, the Principal Secretary to Government, Local Self Government(1A) Department has requested to provide the details as per the list mentioned below in soft copies and GIS layers:-

1.GIS data on number and Locations-

- Transformers, High voltage cables, low voltage cables, high voltage conductors, low voltage conductors, overhead electric lines, Electric stations and Electric Substations.

2.Data on Electricity Standards in Kerala.

3.Data Electricity tariff, generation and Distribution System

4.Data on number and Locations of Powerplants and substations with capacities.

5.Data on current demand and supply status of power.

6.Future Expansion plans of infrastructure and on-going projects.

7.Any other relevant data.

M/s.LEA Associates South Asia Pvt.Ltd requested for the above mentioned data as a part of preparing the master plan and they also submitted the authorization letter from the Special officer, Capital Region Development Project as Planning Consultant.

In view of the above the Chief Engineer (IT,CR&CAPs) has suggested to share the GIS Network Data(Shape file format) of HT/LT lines along with Poles & Transformers done by KSEBL as part of R-APDRP project and GIS data of 11kV network done by KSEBL to M/s.LEA Associates South Asia Pvt.Ltd consultant for OAGC under CRDP-II.

Having considered the matter in detail, the Full Time Directors in its meeting held on 28.01.2021, resolved to accord sanction to share the GIS Network Data (Shape file format) of HT/LT lines along with Poles and Transformers done by KSEBL as part of RAPDRP Project and GIS Data of 11 kV Network done by KSEBL to Power Department and request the Department to share with Local Self Government Department and M/s.LEA Associates South Asia Pvt. Ltd., Consultant for OAGC under CRDP-II.

Further resolved to request the Government in Power Department and Local Self Government Department to execute a Non-disclosure agreement in this regard with M/s.LEA Associates South Asia Pvt Ltd. for sharing the GIS Data.
