## ORDER

As per the B.O. read as 1<sup>st</sup> above, sanction was accorded for fixing the monthly rent of the building owned by Sri. Joseph Thomas, Pallikunnel, Koombara Bazar accommodating Electrical Section, Koombara at ₹10,000/- with effect from 01/08/2017 till a permanent building is constructed in the land offered free of cost for Electrical Section, Koombara.

The Chief Engineer (Distribution North), Kozhikode as per letter read as 2<sup>nd</sup> above reported that the rent agreement of the building had expired on 31/07/2020 and the building owner had requested rent enhancement @ 15% of the existing rent, i.e., ₹11,500/- per month after the expiry of the rent agreement.

As per the B.O. read as 3<sup>rd</sup> above, sanction was accorded for constructing a double storeyed building for accommodating Electrical Section, Koombara in the land offered free of cost by Sri. Shaji Joseph and the plan for the building having a total plinth area of 207.20 m<sup>2</sup> has been approved. It is also reported that some more time will take to construct a building for the Section. Hence sanction is requested to enhance the monthly rent of the building accommodating Electrical Section, Koombara to ₹11,500/- with effect from 01/08/2020.

The matter was placed before the Full Time Directors as per the note read as 4<sup>th</sup> above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 28/01/2021, resolved to accord sanction for enhancing the monthly rent of the building owned by Sri. Joseph Thomas, Pallikunnel, Koombara Bazar accommodating Electrical Section, Koombara at ₹11,500/- with prospective effect, till the Section is shifted to the new building to be constructed in the land offered free of cost for constructing a building for Electrical Section, Koombara.

Orders are issued accordingly.
