ORDER

Based on the directions from Government to KSEBL, to support Government of Kerala in its efforts to contain Covid-19 as per note read as 1 above, the modalities to be followed had been finalized as per minutes read 2nd above, to establish Covid IC hospital facilities in five districts including Idukki District at Rs.10 Crores for each district.

It has been reported that during the review meeting chaired by the Hon'ble Minister for Electricity to review progress and utilization of funds for Idukki District, District Program Manager informed that Rs 9.72 Crores have already been utilized and that they require another Rs.1 Crore for Electrification works required to commission Covid containing facilities such as CT Scan, Digital Radiography, CR Machine, Mammography etc by completing the electrical cabling works and panel board works. Accordingly, as per the minutes of the meeting chaired by the Hon'ble Minister, it has been decided that another Rs.1 Crore may be sanctioned from KSEBL.

Out of the total Rs.50 Crores allotted, it is reported that Rs. 11.33 Crores have been released as on date apart from the various bills that are being processed at District level before

as on date apart from the various bills that are being processed at District level before presenting for payment. Hence based on the request from DMO, Idukki as per letter read 4 above, Chief Engineer (Civil Construction) South as per note read 5 above has requested orders of KSEBL to release Rs.1 Crore for electrification works required to commission Covid containing facilities at Government Medical College, Idukki from the total allotment of Rs 50 Crores ear marked for Covid assistance from KSEBL for 5 districts .

The matter was placed before the Full Time Directors for a decision.

The Full Time Directors in its meeting held on 04.02.2021 decided to accord sanction to release Rs.1 Crore for electrification works required to commission Covid-19 containing facilities at Government Medical College, Idukki, from the total allotment of Rs.50 Crores ear marked for Covid assistance from KSEBL for 5 districts.

Orders are issued accordingly.
