ORDER

Based on the Board Order read as 1st above and Note read as 2nd above, two part tenders were invited for the procurement of 11 kV/433 V, 100 kVA (2225 nos.), 160 kVA (478 nos.) & 250 kVA (76 nos.) BEE Energy Efficiency Level 2 (1 star) Distribution Transformers with ISI marking, required for General Scheme works for the financial year 2020-21, with PAC of Rs. 44.6564 crores. Sixteen firms participated in the tender. The prequalification bids were opened on 30.06.2020. The Pre-Qualification Committee meeting held on 05.11.2020, 17.11.2020 and 02.12.2020 decided to prequalify seven firms. The price bids were opened on 03.12.2020. The Purchase committee meeting held on 18.12.2020 vide Proceedings No. SCM/TA41/PC/20-21/TVM/5222 dated 18.12.2020 approved the proposal for finalizing the tender for placing before the Board of Directors.

The proposal for finalizing the tender was included in the agenda for the 56th meeting of the Board of Directors. Meanwhile, one of the bidders M/s. KEL filed a petition before Kerala State Electricity Regulatory Commission (KSERC) to implement the G.O. (Rt)No.5382/ 2020/Fin dated 18.09.2020. The hearing on the petition was conducted on 30.12.2020. Considering the issues, KSERC issued the following direction vide Order dated 30.12.2020.

"KSEB Ltd. shall implement the Government of Kerala Order no. G.O.(Rt)No.5382/ 2020/Fin dated 18.09.2020 strictly complying with the provisions of Price Preference and Purchase Preference mentioned therein." KSEBL as per Board Order read as 4th above resolved to authorize the Full Time Directors to issue necessary orders to the Chief Engineer (SCM) with regard to the tender and complying the G.O.(Rt)No.5382/2020/Fin dated 18.09.2020 incorporating the provisions of Price and Purchase preference.

The modified proposal in compliance to the G.O.(Rt)No. 5382/2020/Fin dated 18.09.2020 incorporating the provisions of Price and Purchase preference was submitted before the Full Time Directors as per note read as 5th above for sanction.

Having considered the matter in detail, the Full Time Directors in the meeting held on 28.01.2021 resolved to accord sanction to authorize the Chief Engineer (SCM) to place the following Purchase Orders:-

Ltd., Patancheru, Telangana at all inclusive unit variable rate of Rs. 123812.68 (IEEMA variable rate without ceiling). [Basic Price – Rs. 100206.00, Freight charges – Rs. 4560.00, Transit cum one month storage insurance charges – Rs. 160.00, GST@18%- Rs.18886.68], the financial commitment being Rs. 13,78,03,513.00 (Rupees Thirteen Crore Seventy Eight Lakh Three Thousand Five Hundred and Thirteen only).
- 556nos. of 100kVA 1 star Distribution Transformers with M/s Unipower Systems, Kottayam at all inclusive unit variable rate of Rs. 146668.10 (IEEMA variable rate without ceiling). [Basic Price – Rs. 122795.00, Freight charges -Rs. 1500.00, GST @18% - Rs.22373.10], the financial commitment being Rs. 8,15,47,464.00 (Rupees Eight Crore Fifteen Lakh Forty Seven Thousand Four Hundred and Sixty Four only).

- 239nos. of 160kVA 1 star Distribution Transformers with M/s KEL, Kochi at all inclusive unit variable rate of Rs. 201908.62 (IEEMA variable rate without ceiling). [Basic Price - Rs.169209.00, Freight charges - Rs.1900.00, GST@18%- Rs.30799.62], the financial commitment being Rs. 4,82,56,161.00 (Rupees Four Crore Eighty Two Lakh Fifty Six Thousand One Hundred and Sixty One only).
- 239nos. of 160kVA 1 star Distribution Transformers with M/s Unipower Systems, Kottayam at all inclusive unit variable rate of Rs. 208214.38 (IEEMA variable rate without ceiling). [Basic Price - Rs.174452.86, Freight charges - Rs.2000.00, GST@18% - Rs.31761.52], the financial commitment being Rs. 4,97,63,237.00 (Rupees Four Crore Ninety Seven Lakh Sixty Three Thousand Two Hundred and Thirty Seven only).

- 38nos. of 250kVA 1 star Distribution Transformers with M/s Unipower Systems, Kottayam at all inclusive unit variable rate of Rs. 259305.00 (IEEMA variable rate without ceiling). [Basic Price - Rs. 217250.00, Freight charges - Rs. 2500.00, GST @18% - Rs.39555.00], the financial commitment being Rs. 98,53,590.00 (Rupees Ninety Eight Lakh Fifty Three Thousand Five Hundred and Ninety only).
- 38nos. of 250kVA 1 star Distribution Transformers with M/s KEL, Kochi at all inclusive unit variable rate of Rs. 242366.90 (IEEMA variable rate without ceiling). [Basic Price - Rs. 201895.68, Freight charges - Rs. 3500.00, GST@18%- Rs.36971.22], the financial commitment being Rs. 92,09,943.00 (Rupees Ninety Two Lakh Nine Thousand Nine Hundred and Forty Three only).

The total financial commitment for purchase of 2225nos. of 100kVA 1 star Distribution Transformers, 478nos. of 160kVA 1 star Distribution Transformers and 76nos. of 250kVA 1 star Distribution Transformers is Rs. 41,29,30,768/- (Rupees Forty One Crore Twenty Nine Lakh Thirty Thousand Seven Hundred and Sixty Eight only) against the PAC of Rs. 44.6564 crores.

The Full Time Directors noted that on implementation of GO for price preference an increase of Rs. 1,71,54,119/- (Rupees One Crore Seventy One Lakh Fifty Four Thousand One Hundred and Nineteen Only) is incurred than the earlier proposal put up before Board of Directors.

Orders are issued accordingly.
