ORDER

Orders were issued for the regularization of unauthorized drawal of Cables along the electric poles of KSEBL on or before 31.12.2020, as per B.O read as 2nd above, for only those cases which are found feasible and safe and for those which are not in K-FON area; strictly ensuring tagging of cables, subject to the conditions mentioned there in.

The Deputy Chief Engineer, Electrical Circle, Perumbavoor has reported that regularization process under Electrical Circle, Perumbavoor is being done but due to large number of CTV Operators under the Circle, the scheduled progress could not be achieved. Further, the Covid-19 pandemic scenario as well as the LSGD election scenario has delayed the regularization process. It was requested to extend the date for completing the regularization process for a further period of two months up to 28.02.2021.

As per the note read as 4th above, the matter was placed before the Full Time Directors. Having examined the matter in detail, the Full Time Directors in the meeting held on 20.01.2021, resolved to accord sanction to extend the date for completing regularisation of unauthorised cables

drawn along the electric poles of KSEBL, ordered vide B.O dated 09.11.2020 till 31.03.2021, subject to the terms and conditions mentioned in the Board Order.

Orders are issued accordingly.
