Request for electricity connection to a tea shop run by Sri Shajimon, Srayil Veedu, Vadayar P.O, Thalayolaparambu in puramboke land at Vadayar -- Orders issued.

ORDER

Sri Shajimon, Srayil Veedu, Vadayar P.O, Thalayolaparambu, Kottayam, as per the representation read as 1st above, requested electricity connection to his tea shop which is situated in puramboke' land under Thalayolaparambu Grama Panchayath. The petitioner claims that he has been running this tea shop for the past 27 years.

The Executive Engineer in charge, Electrical Circle, Kottayam reported as per letter read as 2nd above, that the petitioner who comes under Electrical Section, Thalayolaparambu has not applied for connection and that on enquiry, the tea shop was understood to be situated in puramboke land. It was also reported that in a similar case, a connection has been effected under Thalayolaparambu Section to a tea shop run by one Sri Thankappan in puramboke land after getting an undertaking from the applicant, as per the decision taken at the Vydyuthi Adalath.

As per the existing rules, and as clarified as per BO read 3rd above, unless it is a domestic connection (with less than 100 sq metre area), or a MILMA Booth or a Horticoop bunk, or places of worship/offices of recognised political parties/ Libraries, Reading Rooms, Premises of Sports, Arts & Cultural Organisations functioning in the premises for more than 5 years, or Government / Aided educational institutions or Anganwadis or Premises in Govt owned land / buildings, ownership document is mandatory for effecting connection.

The Assistant Engineer reported that the tea shop run by the applicant Sri Shajimon has been functioning in the premises for more than 20 years.

The matter of allowing the application from Sri Shajimon, Srayil Veedu, Vadayar P.O, Thalayolaparambu, Kottayam for electricity connection to the tea shop run by him in puramboke land at Vadayar under Electrical Section, Thalayolaparambu, without insisting on ownership documents, on the basis of an undertaking from him that he is willing to get his electricity supply disconnected if any statutory body requests so, was placed before the Full Time Directors as per note read as 4th above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 20/01/2021, resolved to accord sanction to the Assistant Engineer, Electrical Section, Thalayolaparambu, as a special case, to process the application from Sri Shajimon, Srayil Veedu, Vadayar P.O, Thalayolaparambu, Kottayam, for electricity connection to the tea shop run by him in puramboke land at Vadayar, under Electrical Section, Thalayolaparambu, without insisting on ownership documents, on the basis of an undertaking from him that he is willing to get his electricity supply disconnected if any statutory body requests so, and following all other procedures and ensuring safety standards, and also considering that the petitioner has been running this tea shop in the premises for a long period and considering that in a similar case which appeared before the Vydyuthi Adalath, electricity connection has been effected under the same Thalayolaparambu Section to a tea shop run by Sri Thankappan after getting an undertaking from him based on the Adalath decision.

Orders are issued accordingly.
