## ORDER

The formats of agreement to be executed with the consumers registered under Model – I & II of Soura Project had been approved as per Board order read 2 above. The investment and O & M of the plant is by KSEBL under Model II and the power generated from the roof top plants will be sold to consumers at a pre-determined tariff decided by KSEBL. If the Hon'ble Regulatory Commission is not including such non- regulated activity under the head 'Other business', then Special Project Vehicle (SPV) is to be formed for carrying out Model II scheme. The formation of such SPV is under consideration of KSEBL.

Around 4000 nos premises are selected for the project under Model II. In order to handover the locations to the EPC contractors, the consumer agreements are to be executed.

The State Nodal Officer, Soura Project as per note read as 4<sup>th</sup>, suggested that the Assistant Executive Engineers of Electrical Sub Divisions be designated as ' Soura Project- Sub Divisional Engineers' for the purpose of Roof Top Solar Programme and be authorised to execute agreements under Model I and II schemes of Soura Project.

The Government of Kerala have accorded sanction for the hybrid models proposed by KSEBL for the subsidy scheme as per order read as 3<sup>rd</sup> above. The registration of consumers towards the subsidy scheme is to commence soon. The State Nodal Officer, Soura Project suggested that Assistant Engineers of Electrical Sections be entrusted to impart information to the domestic consumers regarding the schemes and to facilitate registration for the subsidy scheme.

Having considered the matter, the Full Time Directors in the meeting held on 22.01.2020

1. Resolved to designate the Assistant Executive Engineers of Electrical Sub Division as 'Soura Project- Sub Divisional Engineers' for the purpose of Roof Top Solar Programme and authorised to execute agreements under Model I and II Schemes Of Soura Project.
2. Further resolved to entrust the Assistant Engineers of Electrical Sections to impart information to the domestic consumers regarding the MNRE Phase II subsidy scheme and to facilitate registration for the subsidy scheme.

Orders are issued accordingly.
