ORDER

Coast Guard Air Enclave, CIAL, Nedumbassery, Kochi is a HT consumer (No.33/8405) of Electrical Section, Kanjoor, under Ele. Circle, Perumbavoor availing 50 kVA power from KSEB Ltd.

The Deputy Chief Engineer, Ele. Circle, Perumbavoor based on the request of the Executive Engineer, Garrison Engineer (I),(CG),MES, Kochi as per the letter read (3) above has forwarded a letter for the enhancement of contract demand from 50 kVA to 100kVA and change of tariff from HT II B general to Military Engineering Service (MES) licensee tariff of the above consumer and sought clarification whether the said HT consumer is covered in the annexure to the modified common agreement read 1 above executed from office on 17.10.2008. It was further requested to accord sanction for executing supplementary /codicil agreement.

SE, DirE/M for Chief Engineer Naval works, Kochi as per letter read as 4th above has forwarded a letter stating that Chief Engineer HQ CE(Coast guard) Goa had authorised GE(I) CG ,Kochi for enhancing the contract demand and change of tariff.

The supply of power (HT/EHT) to various institutions under MES is governed by the Modified Common Agreement executed between KSEB and MES dated 17.10.2008. The list of consumers under MES licensee are annexed to the Modified Common Agreement.

As per clause 4(b) of the above agreement,

" In the event of MES desiring to add new consumers under the licensee, other than that given in the annexure in any of the Electrical Circle in the State, their details such as Name of Consumer and Consumer number shall be added in the Annexure 4(a) of the Common Agreement as the new number."

Further the respective units of MES shall enter into separate codicil agreements with the Deputy Chief Engineers of the Electrical Circles concerned. In order to regularize Coast Guard Air Enclave, under MES licensee, the formalities prescribed in the Modified Common Agreement is to be followed.

The present common agreement was executed by Chief Engineer(Commercial) on behalf of KSEB and by Chief Engineer (Naval Works), Kochi on behalf MES. The common agreement is executed by Chief Engineer (Naval Works), Kochi on behalf MES. In order to modify an agreement the original signatory or a person authorised by the original agreement authority is to be signed.

As per letter read as 5th above, it was requested to Chief Engineer (NW) Kochi to forward his concurrence for making changes in annexure 4(a) of the modified common agreement for including Cost Guard, Air Conclave, Nedumbassery, Kochi under MES licence. Chief Engineer (NW) Kochi as per letter read as 6th above issued concurrence/ authorization for making changes in annexure 4(a) of the Modified Common Agreement for including Cost Guard, Air Conclave, Nedubassery, Kochi under MES licence.

The Deputy Chief Engineer(Commercial &Planning) with full powers of Chief Engineer as per note read as 7th above has suggested that HT consumer No. LCN 33/8408, Coast Guard Air Enclave, CIAL, Nedumbassery, Kochi under Electrical Section, Kanjoor may be included under Military Engineering Service (MES) licensee and Deputy Chief Engineer (Commercial &Planning) with full powers of Chief Engineer may be authorized to amend the Annexure 4(a) to the Modified Common Agreement dated 17.10.2008 between KSEB Ltd and MES for adding the above consumer and the Deputy Chief Engineer, Electrical Circle, Perumbavoor may be authorized to execute the "Codicil agreement" with Garrison Engineer (I),(CG), Kochi.

Having considered the note, the Full Time Directors in its meeting held on 20.1.2021 :

1. Resolved to include HT consumer No. LCN 33/8408, Coast Guard Air Enclave, CIAL, Nedumbassery under Electrical Section, Kanjoor under Military Engineering Service (MES) licensee and to authorize Deputy Chief Engineer (Commercial &Planning) with full powers of Chief Engineer to amend the Annexure 4(a) to the Modified Common Agreement dated 17.10.2008 between KSEB Ltd and MES for

adding the above consumer, based on the concurrence received from Chief Engineer(Naval works) ,Kochi.

2. Further resolved to authorize the Deputy Chief Engineer, Electrical Circle, Perumbavoor to execute the "Codicil agreement" with the Executive Engineer, Garrison Engineer (I), (CG), Kochi for power supply to Coast Guard Air Enclave, CIAL, Nedumbassery at the tariff applicable to MES licensee, in the prescribed proforma, with contract demand of 100kVA ensuring technical feasibility and other formalities, after terminating the present HT agreement with the consumer.

Orders are issued accordingly.
