### ORDER

Sri. Rijil. S, Electricity Worker, Electrical Section, Uchakkada had met a non-fatal accident on 15.07.2018 while he tried to repair a broken service line. The incident has occurred while the incumbent attended to resolve the supply failure of a consumer belonging to Electrical Section, Poozhikunnu, after the duty hours, while proceeding to home and got severely injured on falling down from the electric post. The incumbent has suffered from severe traumatic brain injury with the disability of 100% as per the Disability Certificate read as 3rd above and now surviving in vegetative state.

The Chief Engineer (HRM) forwarded the request for the sanction of Special Disability Leave for a period of 823 days with effect from 15.07.2018 upto 15.10.2020 in respect of Sri. Rijil. S. as per note read as 1<sup>st</sup> paper above.

The maximum period of Special Disability Leave that can be granted in consequence of disability is 24 months as per the prevailing rules (clause 3 & 5 of Rule 97 Part I, KSR). Since the request for the granting of Special Disability Leave is for 823 days, the Special Disability Leave beyond the period of 2 years can be sanctioned only by relaxing the relevant provisions in KSR.

Considering the case in detail along with the Medical Certificate read as 3<sup>rd</sup> above and other similar cases which has been granted the Special Disability Leave beyond the maximum permissible limit of 2 years, the Chairman & Managing Director has ordered to place the matter before the Board of Directors for approval.

Accordingly, the matter was placed before the meeting of Board of Directors as per note read as 5<sup>th</sup> above. Having considered the matter in detail, the Board of Directors in its meeting held on 01.01.2021 resolved to sanction Special Disability Leave to Sri. Rijil. S, Electricity Worker, Electrical Section, Uchakkada, for a period of 823 days with effect from 15.07.2018 upto 15.10.2020 by reckoning the electrical accident as occurred during the course of his employment by relaxing the provisions, under clause 3 & 5 Rule 97 Part I KSR by considering as a special case.

Orders are issued accordingly.
