## **ORDER**

Based on the Board Order read 1 above and Note read 2 above, two part tenders were invited for the supply of 22kV/433V, 160 kVA (9 nos.) & 250 kVA (12 nos.) BEE Energy Efficiency Level 2 (1 star) Distribution Transformers with ISI marking vide Bid No. KSEB/SCM/eP25/2020-21 dated 18.06.2020 required for General Scheme works for the financial year 2020-21, with Probable Amount of Contract of Rs. 90,26,000/-. As only one bid was received even within the extended date of bid submission, the tender was cancelled.

Retender was floated for the procurement vide no. KSEB/SCM/eP43/2020-21 dated 26.08.2020. Only one firm viz. M/s. Toshiba Transmission & Distribution Systems (India) Pvt. Ltd., Telangana submitted tender within the stipulated date and time for re-tender also. The pre-qualification bid was opened on 18.09.2020. The Pre-Qualification Committee meeting held on 02.12.2020 decided to prequalify the firm.

The price bid was opened on 04.12.2020. Final offered rates are as follows.

The all inclusive rate offered in the tender for 160kVA transformer is approximately 2.31% below the rate of previous tender. For 250kVA transformer, there was no purchase for last 10 years. The total financial commitment for 9nos. of 160kVA and 12nos. of 250kVA Transformers comes to Rs. 94,65,535/-.

As per delegation of power, Chief Engineer can accept tenders for purchase of materials upto Rs. 1.5 crore. Even though the purchase amount in this case is less than

Rs. 1.5 crore, being a single bid, the matter was taken up with the Full Time Directors as per note read 3 above for sanction.

Having considered the matter in detail, the Full Time Directors in the meeting held on 20.01.2021 decided to authorize the Chief Engineer (SCM) to place Purchase Orders with M/s Toshiba Transmission & Distribution Systems (India) Pvt. Ltd., Telangana for the following:-

- i. Supply of 9nos. of 160kVA 22kV/433V, BEE Energy Efficiency Level 2 (1 star) Distribution Transformers with ISI marking at all inclusive unit variable rate of Rs. 429944.80 (IEEMA variable rate without ceiling). [Basic Price Rs. 350010.00, Freight charges Rs. 13800.00, Transit cum one month storage insurance charge Rs. 550.00, GST@18%- Rs.65584.80], total financial commitment being Rs. 3869503.00.
- ii. Supply of 12 nos. of 250kVA, 22kV/433V, BEE Energy Efficiency Level 2 (1 star) Distribution Transformers with ISI marking at all inclusive unit variable rate of Rs. 466336.00 (IEEMA variable rate without ceiling). [Basic Price Rs. 380800.00, Freight charges Rs. 13800.00, Transit cum one month storage insurance charge Rs. 600.00, GST@18%- Rs.71136.00], total financial commitment being Rs. 5596032.00.

The total financial commitment for 9nos. of 160kVA and 12nos. of 250kVA, 22kV/433V, BEE Energy Efficiency Level 2 (1 star) Distribution Transformers with ISI marking is Rs. 9465535/- (Rupees Ninety Four Lakh Sixty Five Thousand Five Hundred and Thirty Five only).
