

**Abstract**

Standardisation of Pullikkanam 11kV feeder from 66kV Sub Station Peermade (33kV Substation Vagamon) under Electrical Section, Peermade- request for accepting single tender after retendering– Sanction Accorded – Orders issued

**ORDER**

Competitive E-tenders were invited by the Executive Engineer, Project Management Unit, Thodupuzha for the work of Standardisation of Pullikkanam 11kV feeder from 66kV substation Peermade (33kV Substation Vagamon) under Electrical Section, Peermade with a PAC of Rs.6,47,107/-, from the licensed contractors or those having 5 years of experience, after giving wide publicity as per norms. Only one tender was received within the stipulated time. Hence, the time of submission was extended upto 28.07.2020. No more response was received even after extending the time. Hence, the work was re-tendered.

On retendering, only one tender was received till the last date of 03.09.2020 and hence the time was extended upto 09.09.2020 anticipating more competition. After granting time extension one more tender was received. Hence, the tender was opened on 11.09.2020.

The lowest tender was submitted by Sri. Dhanapal A. P. at 0.01% below the estimate rate. He is an experienced contractor. The other tender was submitted by Sri. Sebastian M. at the estimate rate. But, he is a PWD registered contractor and has no experience in execution of Electrical Installation. Hence, there is only one valid tender viz. that submitted by Sri. Dhanapal A.P.

Since, the subject work was tendered twice after granting sufficient time extension, the chance to get better offer on further re-tendering is very remote. Hence, rock bottom rate was sought from the tenderer. The contractor has expressed his willingness to carry out the work at 1% below the estimate rate.

Since, the tenderer is having 9 years of experience in the execution of similar works, the Chief Engineer Distribution Central has recommended to award the subject work to the lone

safety aspects as well as to maintain the statutory clearance and to reduce interruption in the remote area in Idukki District. Hence, sanction is requested for awarding the work of Standardisation of Pullikkanam 11kV feeder from 66kV substation Peermade under Electrical Section, Peermade to the single tenderer, Sri. Dhanapal A. P. at his quoted rock bottom rate.

The matter was placed before the Full Time Directors as per note read as 2<sup>nd</sup> above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 07.01.2021, resolved to accord sanction to the Deputy Chief Engineer, Electrical Circle, Thodupuzha for the accepting single tender for the work of Standardisation of Pullikkanam 11kV feeder from 66kV substation Peermade under Electrical Section, Peermade and to issue work order to the single tenderer Sri. Dhanapal A.P. at his quoted rate of 1% below the estimate rate.

Orders are issued accordingly.
